REASONS FOR DECISION

Evidence and materials considered:

- 1. Video footage of the incident.
- 2. Referee's red card report.
- 3. Medical evidence in respect of the injured player
- 4. Player's written submissions.

Red card upheld

1. Foul play, contrary to Law 9.20(a). The Committee considered the Player's submission that the offence should have been under Law 9.20 (b) as he considers that in his attempt to clear out the other player he unintentionally made contact above the line of the shoulders and did not charge. The Committee viewed the clips, and agreed with the Match Officials' assessment of charging as the Player entered the ruck with a forceful forward movement and momentum. Law 9.20 (a) more accurately reflected the Player's actions, rather than Law 9.20 (b)

2. The Player charged into the ruck and made no attempt to wrap his arms and in doing so made direct contact with the other player's neck and head with a high degree of danger.

Sanction:

- 1. The minimum mandated entry point is mid-range with a starting point of 6 weeks.
- 2. The Player admitted foul play and accepted that the red card was warranted; he has no previous suspensions, citings or red cards. He receives full mitigation of 3 weeks.
- 3. There are no aggravating factors.
- 4. Therefore, the proposed sanction is a suspension of 3 weeks.
- 5. The Player is eligible for the coaching intervention programme. The FPRC approves that course should he wish to apply for it. Successful completion of that will reduce the suspension by one week/match.
