The Player accepted that his actions were reckless though not deliberate, and the video footage vouchsafed this. Given the contact to the head, the recklessness of the actions and the resulting injury, the RC test is met.

REASONS FOR DECISION

- 1. The action of lifting the leg in proximity of an oncoming opponent was reckless, as the player accepted.
- 2. This resulted in contact with the face of an opponent, who sustained a laceration requiring stitches.
- 3. Contravention of Law 9.11 thus demonstrated.
- 4. Contact with the head means mid-range minimum.
- 5. Nothing in the case to take it to top range. Hence 6 week starting point.
- 6. Clean record and full mitigation available: 50%.
- 7. 3 match suspension; reduced to two if coaching intervention programme utilised.
