#### **REASONS FOR DECISION**

#### Evidence and materials considered:

- 1. Video footage of the incident.
- 2. Referee's red card report.
- 3. Medical evidence in respect of the injured player
- 4. Player's written submissions.

# Red card upheld

- 5. Foul play, contrary to Law 9.20(a).
- 6. The Player charged into the ruck with a tucked arm and his shoulder came into direct and strong contact with the other Players head;
- 7. The Player entered a static ruck at speed and there was a high degree of danger

## Sanction:

- 8. The minimum mandated entry point is mid-range with a starting point of 6 weeks.
- 9. The Player admitted foul play and accepted that the red card was warranted; he has no previous suspensions or red cards. He receives full mitigation of 3 weeks.
- 10. There are no aggravating factors.
- 11. Therefore, the proposed sanction is a suspension of 3 weeks.
- 12. The Player is eligible for the coaching intervention programme which the FPRC approves should he wish to apply for it. Successful completion of the course will reduce the suspension by one week/match.
