## **REASONS FOR DECISION**

### **Evidence**

- 1. The FPRC received and considered the following material:
  - a. video clip of the incident;
  - b. five (5) Match Official Reports from the Referee, Assistant Referees, TMO and FPRO;
  - c. victim player's (Japan 14) statement and medical report;
  - d. the Player's submission. There Player accepted foul play but did not accept that the Red Card threshold was met.

### Decision

- 2. The FPRC upheld the Red Card applying the Head Contact Process (2023):
  - a. <u>head contact</u> Yes. The Player's right shoulder made contact with Japan #14's neck and/or head;
  - foul play Yes. The Player's actions were reckless. He was upright and he admitted he got his positioning wrong;
  - c. <u>degree of danger</u> High. The Player was dynamic. There was high force (Japan #14 described "intense contact"); and
  - d. <u>mitigation</u> None. The Player had clear line of sight. He did not make an attempt to change his height. There was no significant drop or movement from Japan #14.

#### Sanction

- 3. The FPRC applied the mandatory mid-range entry point of 6 weeks due to the head contact. There was no injury and the victim player played on. There was no basis for moving to top end.
- 4. Based on the Player's clean record and experience the FPRC applied full mitigation 3 weeks (reducing sanction to 3 weeks). The player is eligible for the Coaching Intervention Programme, if applicable. If the Player applies and completes the programme, the suspension may be reduced to two (2) weeks.

#### Note:

In the FPRC's view, the appliable foul play for this incident should be Law 9.13 – Dangerous Tackling instead of Law 9.11. Whilst there are no provisions under the Expedited Off-Field Sanctioning process which would permit the FPRC to amend the appliable foul play, the FPRC notes the mandatory mid-range entry point for both 9.11 and 9.13 is the same.
