REASONS FOR DECISION					

Evidence

- 1. The FPRC received and considered the following material:
 - a. video clips of the incident;
 - b. two (2) Match Official Reports from the Referee and TMO;
 - c. medical report, reflecting that the victim player Namibia #9 was removed from play for displaying obvious onpitch signs of concussion (Criteria 1) under the HIA protocol.
 - d. the Player's submissions.

Decision

- 2. The Red Card threshold was met. The FPRC upheld the Red Card applying the Head Contact Process (2023):
 - a. <u>head contact</u> Yes. The Player's head made direct contact with the Namibia #9's face and/or head;
 - b. <u>foul play</u> Yes. The Player's actions were reckless. He was always upright;
 - c. <u>degree of danger</u> High. There was direct head-on-head contact. The Player was dynamic. There was high force as the Player approached at pace without slowing down; and
 - d. <u>mitigation</u> None. The Player had clear line of sight. He did not make an attempt to change his height or speed. He did not have control. There was no significant drop or movement from Namibia #9

Sanction

- 3. The FPRC applied the mandatory mid-range entry point of 6 weeks due to the head contact.
- 4. Based on the Player's clean disciplinary record the FPRC applied full mitigation 3 weeks (reducing sanction to 3 weeks).
- 5. In accordance with Reg 17.21.3 (e) each tournament or Series of Matches played over a weekend shall be considered to equate to one week for the purposes of calculating the suspension of a Player arising from a fifteen-a-side Match, which applies to the following tournaments on the Player's schedule
 - 22 -23 November 2025 Campeonato Paulista
 - 29 -30 November 2025 Campeonato Paulista / Lions
 - 6-7 December 2025 BR Sevens
- 6. The player is eligible for the Coaching Intervention Programme. If the Player applies and completes the programme, the suspension may be reduced to two (2) weeks.
